### **Important Preparations:**

 Bring photos!! This is the easiest way to convey to your stylist or makeup artist what you're looking to achieve.

#### • For hair styling:

- Refrain from washing your hair the night before or morning of the wedding, as formal styles tend to hold best with the natural oils of unwashed hair. If you are scheduled for a blowout, a shampoo is included in your appointment.
- Wear a top that can easily be unzipped/unbuttoned to prevent any problems when changing into your formalwear.

#### • For makeup:

- Arrive with a clean, moisturized face to ensure smooth makeup application. It is also your responsibility to inform the makeup artist of any allergies or issues concerning your skin.
- We do not provide take-home lip color, so if you would like to use your own lipstick/gloss so that you can reapply throughout the day, feel free to bring it in for your makeup artist to see!

#### • For the Bride:

- Arrive at your appointment with your veil or any headpieces you plan to wear. It may also be helpful to bring these items to your trial appointment if you choose to schedule one.
- Bring a photo of your dress! This will help both your makeup artist
   and hairstylist customize a look that is perfect for you.



## Wedding Contract Terms

**BOOKINGS:** For parties larger than 2, Haircut 101 requires a deposit to reserve your date. The deposit will be **25%** of the quoted total. The date will not be officially reserved until the deposit is received and contract has been signed.

<u>CANCELLATIONS</u>: Haircut 101 wants to provide you with the best possible experience on your special day. Because our service providers are paid based on performance, not by the hour, Haircut 101 adheres to a strict cancellation policy, and for this reason we require credit card information to be kept on file. If you must cancel less than 2 Weeks in advance, penalties are as follows:

- 2 week cancellations will be charged 25% of the total amount of services to credit card on file
- 1 week cancellations will be charged 50% of the total amount of services on file, 48 hour cancellations will be charged 75% of the total amount of services to credit card on file
- 24 hours or less/no show cancellations will be charged 100% of services to credit card on file.

<u>LATE ARRIVALS</u>: In order to ensure accurate timing and an enjoyable experience for you and your stylists, we ask that you arrive 15 minutes prior to your appointment time(s). If the wedding party is running late, we will perform services to the best of our ability under the time restraints we have. We reserve the right to charge for the services booked rather than services performed in the event of a late arrival.
